The rebate program: how it works

Step 1: Define your rebate:

New Course Rebates:

For each TORO mower, aerator, bunker rake, turf utility vehicle (20 h.p. or greater), irrigation sprinkler, irrigation satellite and irrigation central control unit purchased by a new course that is an EGCOA member, TORO shall pay the EGCOA a fee equal to 1% of the cost of the product and accessories, excluding sales tax and shipping costs.

Note: TORO shall not be obligated to pay such fee on such sales if such EGCOA member is already receiving "national account" pricing, rebate(s) or terms on such sale by virtue of a separate national account agreement between TORO and a third party national account.



Step 2: Fill out the EGCOA/TORO Rebate Form

On the next page, you can find the form to receive your TORO rebate: please fax this form for any purchases, that fit in the above description (max. 6 months after your purchases) to us.



Step 3: Include the original invoice

To complete the rebate, we need to receive a copy of the original invoice of your purchases. Please enclose or fax this form together with the rebate form and send this to the EGCOA office.

After TORO transferred the rebate to the EGCOA, we will transfer it to you.
